

## Washington DECA 2021 Fall Leadership Conference Proof of Vaccination Policy

Updated October 5, 2021



**VACCINATION MANDATE**

All conference attendees and volunteers, ages 12 and over, will be required to provide proof of COVID-19 vaccination for entry to the 2021 Washington DECA Fall Leadership Conference.

If unvaccinated, conference attendees and volunteers have the option to provide proof of a negative COVID test. The COVID test must have been taken after 12:00 p.m. on November 6, 2021.

**MASK MANDATE**

In accordance with current Washington state and King County mask mandates, all conference attendees will also be required to wear a mask at all times, except while actively eating or drinking, regardless of vaccination status. This includes both indoor and outdoor areas of the conference.

**HEALTH & SAFETY UPDATES**

The Hyatt Regency Bellevue and Washington DECA continues to follow all state and local public health and government requirements for conferences and indoor/outdoor activities to ensure the safety and well-being of all conference attendees.

*Tukwila, Wash.* – In compliance with the King County vaccination mandate from Washington state, all conference attendees, volunteers, exhibitors, judges, chaperones, and staff, ages 12 and over, attending the 2021 Washington DECA Fall Leadership Conference will be required to provide proof of vaccination upon entry. If unvaccinated, conference attendees have the option to provide proof of a negative COVID test. **The COVID test must have been taken after 12:00 p.m. on Saturday, November 6, 2021.** This ensures the delegate can access food venues and public businesses for the full duration of the conference.

During conference check-in, if a delegate or volunteer cannot provide vaccine verification or proof of a negative COVID test (see above), the attendee will be placed in quarantine and their parent/guardian will be notified to pick-up the delegate. Conference volunteers will be unable to participate in the conference.

It is the responsibility of the chapter's advisor and school district to confirm all conference delegates are vaccinated or can provide a negative COVID test that meets the standards aforementioned prior to transporting them to the conference. Throughout the duration of the conference, the Hyatt Regency Bellevue is responsible for enforcing this policy.

To ensure you are equipped to verify your proof of vaccination, King County requirements are outlined below:

- 1) Verification of vaccination may be established by any of the following methods of documentation:
  - a. CDC COVID-19 Vaccine Record Card, or photo of CDC Vaccine Record Card.
  - b. QR Code, Digital or printed certificate from <http://www.MyIRMobile.com>, 833-829-4357.
    - i. WA Department of Health partner website, My Immunization Records
  - c. Vaccine administration record from a vaccine provider, including an individual's doctor, pharmacy, or other official immunization record from within or outside the U.S., including a photo or photocopy.
  - d. Any other digital vaccine card specified by Public Health – Seattle & King County as sufficient to demonstrate proof of vaccination status (VeriFLY, Clear, etc.).
- 2) As an alternative to providing vaccine verification, prior to entry individuals must provide digital or printed documentation from a testing agent, including a laboratory, health care provider, or pharmacy of:
  - a. A negative FDA-approved PCR test administered within the previous 72 hours of the conference start time. The test must be taken no earlier than noon on Saturday, November 6, 2021. This will ensure the delegate is covered during the entire conference and can enter restaurants, public businesses, etc.
  - b. Medical and religious vaccine exemptions are not accepted in place of vaccine verification or documentation of a negative COVID test.

In accordance with the current Washington state and King County mask mandate, all conference attendees will also be required to wear a mask at all times, except while actively eating or drinking, regardless of vaccination status. Please be mindful that the surrounding Bellevue restaurants, shopping areas, and public places are following the same King Country mask mandate.

If a conference attendee is providing proof of vaccination, the delegate must be fully vaccinated which is defined as a minimum of two weeks following the second dose of the Pfizer or Moderna vaccines or a minimum of two weeks following the single dose Johnson & Johnson vaccine. Those who have only received one dose of the Pfizer or Moderna vaccine or are not yet beyond the two week fully vaccinated window will need to provide a negative COVID test (see guidelines above).
